

AKT.IO Advent Calendar

Automata ICO Limited (hereinafter referred to as "AKT.IO", "Organizer" "Automata") is a Company incorporated in Ireland with its registered office at 3rd Floor Ormond Building, 31-36 Ormond Quay Upper, Dublin 7, D07 Ee37, Ireland. **Automata** is registered in Ireland under number 690280. **Automata** is hosting a giveaway on its social media account on Instagram, Facebook and Twitter (hereinafter referred to as the "Competition"). Participation is free of charge and participants are not required to make a purchase to attend.

1. General conditions of participation / Competition

Participating in the AKT.IO Contest is based exclusively on these Terms and Conditions. To participate in the Contest, you must have a fully verified account with AKT.IO and meet the conditions of the contest according to the day of the Advent Calendar. All accounts in the process of being deleted or inaccessible for legal matters won't be taken into consideration. The Advent Calendar will consist of 6 mini-games on our various social networks. Each mini-game will require an action on your part in order to enter the draw for the day's prize. Participation is free and signing up for a particular membership and/or status will not increase a Participant's chances of winning.

Please note that by posting a photo, video or other material and identifying AKT.IO, the Participant grants AKT.IO the right to publish, distribute, copy and use such content in connection with the Contest. Article 10 applies.

Description of the mini-games:

1. On Twitter: Subscription to our account + "tag" 2 people among your relatives in a comment + "retweet" // On Instagram: share post or "personal addition" in story. Referral of a person from the application, validation of the participation by sharing the post. **Random draw among the sponsors of the day** who validated their participation by sharing the post.
2. Buying AKTIO or the crypto listed this day, validation of the participation by sharing the day's post. **Random draw among the trades of the day** for validated participants.
3. Day of a match in the World Cup (semi-finals 13th & 14th december + final 18th december), bet on the exact score of the match by sharing our post. **Online draw among the good scores.**
4. Guess the next token listed in the application. **First one to find it wins.**
5. Create a tweet to convince people to become AKTers - use a meme or gif. Selection of a short list by the AKT team, **vote for the funniest by the community** among the short list.

2. Eligibility for Participation

Any participant certifies the knowledge and acceptance of these rules without any reservation or modification.

Participants must be of legal age (18 years or older) and must be fully registered on the AKT.IO app to receive their winnings. AKT reserves the right to check the eligibility of the winners.

Employees of AKT.IO are excluded from participating in the Competition.

Participants may only participate once for each day. Commenting more than once will not increase your chances of winning.

AKT.IO reserves the right, at its sole discretion, to disqualify and exclude any Participant who is suspected to infringe the present T&Cs, the T&Cs of AKT.IO application or any laws against generally accepted good practices or public order. In this case, the excluded Participant will not be eligible to win.

In general, the participant guarantees Automata against all recourse, actions or claims that could be made, in any capacity whatsoever, by any third party, on the occasion of the exercise of the rights assigned to the present agreement and, more generally, on the basis of all the guarantees and commitments made under the present agreement, and consequently undertakes to bear all the costs, damages, fees and disbursements, as time goes by, suffered by Automata. Automata reserves the right to carry out any verification in application of the present rules.

Individuals who have made use of unauthorized aids or other kinds of manipulation to gain an advantage will also be excluded. In such cases, prizes may also be rescinded and recalled, if necessary.

3. Competition period

The Contest period is from December 1, 2022 at 08:00 AM CET until December 25, 19:00 CET. Entries outside the Contest period are not eligible to win the prize. Each competition starts when the game is posted online on our social media, and ends at 23:59 (UTC +1) the same day.

4. Prize

Twenty-five winners of the twenty-five days of games (1 winner / day) will have the opportunity to win one of the following types of prizes (according to Automata choice):

- AKTIO coins (amount varies depending on the day)
- Other crypto currencies (token and amount defined according to the prices of the game day)
- AKTIO goodies
- AirPods (2 pairs)
- Xbox série X (1 console put into play)
- 2 Apple Mousse
- 2 Apple Keyboard
- 2 Ipad

Prize claims are not transferable.

The prize is only valid for current AKT.IO customers with an active account at the moment of the game participation AND of the drawn.

The AKTIO Coins won at the end of the contest will be visible on the user's profile. It will be stacked for a period of 12 (twelve) months starting at the end of the contest.

5. Announcement of the winners

The winners will be announced individually by the AKT.IO team via social networks or by email.

AKT.IO may further share content provided by the winners as described in clause 1 and may announce the names of the winners. Winners must share their registered AKT.IO email address, AKT.IO IBAN and date of birth with AKT.IO in order to facilitate prize fulfillment.

Winners should be aware that they will need to provide a valid address for the shipping of some prizes.

6. Premature closure of the Competition

AKT.IO reserves the right to cancel the Competition at any time without prior notice. In particular, but not limited to, AKT.IO may cancel the Competition in case of technical issues (e.g. computer viruses, manipulation or hard/software errors), or if, due to legal reasons, the Competition cannot be properly implemented. Should a Participant be cause for the cancellation of the Competition, AKT.IO may demand compensation for damage.

7. Liability

AKT.IO shall use its reasonable endeavors in the organization and management of this Competition. If, however, damages occur resulting from the Competition itself, from publishing the winner's name or for any other reason AKT.IO will accept no liability. AKT.IO takes no responsibility for potential print or spelling mistakes, as well as other similar errors of any other kind in published material.

AKT will not accept responsibility for any mistaken address provided by a winner, as well as any shipping issue originating from a provider or transportation company.

8. Data protection

AKT.IO, as the data controller, does process the Participant's personal data specifically for the organization of the Contest and the awarding of the Prize. When using our application, our Privacy Policy applies. For the use of AKT.IO social media channels (Instagram, Facebook, Twitter, Medium), we refer to the Privacy Policy of these social media.

9. Promotion on social media

AKT.IO is the sole organizer of the Competition. The Competition is in no way sponsored, endorsed, administered by or associated with Instagram, Facebook or Twitter.

10. Responsibility for content

Participants assume responsibility for all content they submit for the Competition. If the Participant has posted a photo, video or other material and has tagged AKT.IO, they must guarantee that the material submitted is not illegal, offensive in any way and cannot be construed as libel towards third parties. Submission or publication of any advertisements or promotional material is not permitted. Content that does not comply with the present T&Cs may be altered or removed by AKT.IO without prior warning at its sole discretion.
